This event is scheduled as a two day event; all cars will compete both days. A driver unable to compete on either day forfeits all timed runs offered for that day. A driver showing up for registration and tech inspection after timed runs have started forfeits any missed runs. This event is run under the SCCA Time Trials Rules (TTR) and the PHA Supplemental Rules

<u>APPLICATION:</u> Application blanks must be filled in completely and returned to the respondent indicated on the entry blank. Payment in the form of check or money order or cash (if paid in person) must accompany the completed application form. Entries will be accepted on a first come first served basis. Refunds for cancellations will be at the discretion of the Event Organizer. Each driver must submit a separate application. Two drivers per car will be permitted. If there are any questions or special requests, contact the Organizer whose name and telephone number are listed on the entry form.

**ENTRY LIMITS:** The first **100 paid** entries will be firm entries. All applications postmarked before the specified date (if any) will be considered early entries and will be given an early entry discount.

**NOVICES:** If you are a novice, and this is your first Time Trial event, consider obtaining your Time Trial Novice permit two weeks prior to the event. Go to <a href="https://timetrials.scca.com/pages/driver-eligibility">https://timetrials.scca.com/pages/driver-eligibility</a> to apply for your permit. There is no fee for this!

#### SCCA MEMBERSHIPS AND TIME TRIAL LICENSES / NOVICE LICENSES

All Participants must have a valid SCCA membership, Time Trial License / Novice TT License, or valid competition license

- SCCA Memberships and Time Trial Novice Licenses will be available at **Friday night** registration **ONLY**. While you can do this at Friday registration, it is highly recommended you obtain this from SCCA two weeks prior to the event.
- SCCA membership through NEPA-SCCA is \$85.00.
- SCCA Time Trial license is free
- The SCCA does not accept cash. You may pay by credit card (Visa or Master Card), or check / Money Order made payable to 'SCCA'. If you are paying by check / Money Order, you will need separate checks; one for the membership payment and another for the license payment.
- Giant's Despair Hillclimb can not accept cash for SCCA membership and licenses.
