Rally America, NASA Rally Sport, Canadian Association of Rally Sport, SCCA. <u>C.</u> Vehicle must meet all regulations of one of the above sanctioned bodies. <u>D.</u> vehicle must have entered and passed tech in an event in one of the above sanctioning bodies in the last five years. <u>E.</u> Certain items required for rally competition may be removed from vehicle. The above motion was tabled based on a Motion: John Stinsman / 2<sup>nd</sup>: Rich Rock.
